- 4.3. Third-party cookies help us understand how our website performs and how you interact with it. They play a key role in keeping our services secure, analysing performance, and ultimately providing you with a faster, smoother, and more personalized experience.
- 4.4. We collect some information when you:
 - Fill in a form (like to ask a question, sign up for an Open Day, or apply for a course)
 - Sign up for emails or newsletters.

 - Essential cookies these help the website work properly. You can't turn these off.
 - Analytics cookies these help us understand what pages people visit.
 - Advertising cookies these help us deliver adverts based on what you've looked at.
 - Content cookies like YouTube or map features, which may use their own cookies.

7. Google Analytics

7.1. We use Google Analytics to gather standard internet log data and insights into visitor behaviour. This helps us understand things like how many people visit different parts of our site. All information is processed in a way that does not personally identify you. Google Analytics also collects search terms used on our website to help us improve both our content and search functionality.

8. Sharing Your Information

- 8.1. We will never sell your information. We only share it with trusted partners when:

 - It's necessary to fulfil your request (for example, booking an event)
